By continuing this registration process through to completion, I HEREBY CERTIFY THAT I HAVE READ THIS DOCUMENT; AND, I UNDERSTAND ITS CONTENT.

- 1. Authority to Register and/or to Act as Agent. I REPRESENT AND WARRANT to Perimeter Bicycling Association of America, Inc. ("Perimeter Bicycling") that I have full legal authority to complete this event registration, including full authority to make use of the credit or debit card to which registration fees will be charged. In addition, if I am registering third parties, I represent and warrant that I have been duly authorized to act as agent on behalf of such parties in performing this event registration. By proceeding with this event registration, I agree that the terms of this Accident Waiver and Release of Liability and registration agreement shall apply equally to me and to any third parties for whom I am acting as agent. Compliance with Children's Online Privacy Protection Act (COPPA). Perimeter Bicycling makes no warranty that the Perimeter Bicycling website services will be uninterrupted, secure or error free. Perimeter Bicycling does not guarantee the accuracy or completeness of any information in, or provided in connection with, the Perimeter Bicycling website. Perimeter Bicycling is NOT responsible for any errors or omissions, or for the results obtained from the use of such information. I understand and agree that any material and/or data downloaded or otherwise obtained through the use of the Perimeter Bicycling website is at my own discretion and risk and that I will be solely responsible for any damage to my own computer system or loss of data that results from the download of such material and/or data.

3. Acknowledgment of RISKS. I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. Cyclists have accidents, and crash. Crashing in this cycling event can result in property loss, serious injury, and even death. Furthermore, this event uses open public roads which may or may not be maintained by cities, the county and the state. The course utilizes roads that are open to vehicular traffic. I agree and understand that Perimeter Bicycling is not responsible for the condition and/or maintenance of the roads, or for vehicular traffic. ROAD HAZARDS are always possible, and in agreeing to this Accident Waiver, I acknowledge and understand that I must be alert to avoid all ROAD HAZARDS which may include but are not limited to: pot holes, uneven pavement, road debris, motor vehicles, unexpected construction, etc.

The RISKS of participating in this event include, but are not limited to, those mentioned above, and those caused by other cyclists, road hazards, terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, road conditions, traffic control cones and devices, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration.

- 8. NO ASSISTED/MOTORIZED bicycles. I understand that the bicycle I ride in this event must be 100% human powered and that utilizing a motor assisted (gas or electric) bicycle may result in disqualification from the event and that there will NOT be a refund of any kind.
- 9. EVENT RULES. I understand that I must familiarize myself with the rules of this event and violation of any rule may result in disqualification or time penalty.
- 10. PERSONAL BELONGINGS. I understand that I am completely responsible for all my personal items including but not limited to cameras, cell/mobile phones, clothing, bicycles, etc., and that I shall not leave them with any staff, volunteer or official. I understand that for the safety of all participants, I shall not leave my personal belongings unattended as they may be confiscated and disposed of

I understand that I am required to personally pick up my own event packet and timing device/chip (see Paragraph 12.) for this event at the ?EXPO / PACKET PICK UP? location described by Perimeter Bicycling. I understand that I must and show a picture ID to receive the packet and timing chip. I understand that no agent or substitute may act on my behalf at EXPO/PACKET PICK UP.
- 12. TIMING DEVICE/CHIP. I understand that I will receive a timing device (transponder) to be mounted on my bicycle during the event so that a finish time can be electronically recorded for me. I understand that I am fully responsible for mounting this device properly on my bicycle per the instructions given with the device and that if I do not mount the device properly, no time will be recorded for me. Further, I understand that my time is recorded as ?gun time,? i.e., my time begins with the ?starting gun.?
- 13. NO REFUNDS, NO TRANSFERS. I understand that ALL amounts paid and contributions turned in to Perimeter Bicycling are NOT REFUNDABLE and are NOT TRANSFERABLE to any person or towards any other event. Rider numbers assigned for the event are NOT TRANSFERABLE to another person or event.
- 14. APPLICABLE LAW; Consent to JURISDICTION. The Perimeter Bicycling sites (excluding linked sites) are controlled by Perimeter Bicycling from its offices within the State of Arizona, United States of America. By completing this event registration, both I and Perimeter Bicycling agree that the statutes and laws of the State of Arizona, without regard to the conflict of laws principles thereof, will apply to all matters relating to this event registration, this Accident Waiver and Release of Liability, or other use of the Perimeter Bicycling sites. I AGREE that exclusive jurisdiction for any dispute with Perimeter Bicycling resides in the courts of the State of Arizona and I further agree and expressly consent to the exercise of personal jurisdiction in the courts of the State of Arizona in connection with any dispute including any claim involving Perimeter Bicycling or its affiliates, subsidiaries, employees, contractors, officers, directors, telecommunication providers and content providers. I AGREE that venue shall be exclusively in Pima County, Arizona.
- 15. SEVERABILITY. If any provision of this Accident Waiver and Release of Liability shall be unlawful, void, or for any reason unenforceable, then that provision shall be deemed severable from this Accident Waiver and Release of Liability and shall not affect the validity and enforceability of any remaining provisions.
